#### **OVERVIEW**

#### **OVERVIEW**

#### **DETAILED REPORT**

#### **Purpose**

The purpose of this report is to review and endorse an *Adelaide Plains Council Historical Committee* (previously Mallala Museum) – Committee Members' Honour Board Procedure.

#### **Background/History**

At the 1 September 2021 *Adelaide Plains Council Historical Committee (APCHC)* meeting, the below resolution was endorsed by Members.

7.1 APCHC (Mallala Museum) – Honour Board – Committee Members

"that the Adelaide Plains Council Historical Committee, having considered Item 7.1 – APCHC – Mallala Museum – Honour Board – Committee Members dated 1 September 2021, receives and notes the report and in doing so instructs the Manager Library and Community to write an Honour Board Procedure to be tabled at the October 2021 APCHC meeting and make the necessary arrangements for purchasing an Honour Board as detailed in this report."

**CARRIED** 

Members agreed to proceed with purchasing an Honour Board to recognise the achievements of Committee Members who have served a minimum of ten years on the Committee. It was also decided that the Manager Library and Community be asked to write an *Honour Board Procedure*, based on the discussions that arose at the September 2021 *APCHC* meeting.

The Manager Library and Community has engaged the services of *Prestige Trophy and Engraving* (preferred Council vendor) to supply the Honour Board. The timber Honour Board is 80 cm tall by 100 cm wide and will include the 18 names of Committee Members who are already 'eligible' to be listed. The Board will have two columns – those members' names who have served ten or more years on the Committee will be listed on the left hand column, which ensures that there will be sufficient space to add in the future up to another 20 members' names.

#### **Discussion**

The Manager Library and Community has prepared an *APCHC* (*Mallala Museum*) – *Committee Members' Honour Board Procedure* – **Attachment 1**, based on the outcome of discussions from last month's *APCHC* meeting.

Lastly, Members will also need to determine an agreed location at the Museum to hang the Honour Board, preferably in a prominent and visible spot.

#### Conclusion

Members need to review the *APCHC (Mallala Museum) – Committee Members' Honour Board Procedure* – **Attachment 1**. Any further changes or amendments need to be agreed by the majority of Members before the final version is endorsed. A procedure will ensure consistency, particularly in the future, when further Members' names are being considered for adding to the Honour Board.

# Adelaide Plains Council Historical Committee (Mallala Museum) Committee Members' Honour Board Procedure

(adopted October 2021 APCHC meeting)

- Titling of Committee Members' names use of first name and surname only.
   eg Margaret Tiller
- 2. Format for the years of service number of years of service only, not dates served on the Committee.
  - eg James East 12 years
- 3. Years of service does not need to be continual, however **minimum** number of years for name to be considered to be added to the Honour Board is **10 years.**
- 4. The Committee will consider at its November meeting (eg annually) if any Members' names need to be added to the Board and/ or their completed years of service. An updated decision report will be provided for the Committee's consideration.
  - 4.1 If the Member is still serving and has reached 10 years of service their name may be considered, subject to cost, to be added to the Board their years of service may be added when formally retired from the Committee.
  - 4.2 If the Member's name has been added to the Board and they have formally retired from the Committee, their years of service may be added to the Board, subject to cost.
  - 4.3 Depending on the number of additions required, eg adding of new Members' names and/or years of service, the Committee may agree to defer updating the Board to every two years.
- 5. The Committee does not require written permission from Committee Members (or former Members, or, if deceased, their family) to add names and/or years of service to the Honour Board.
