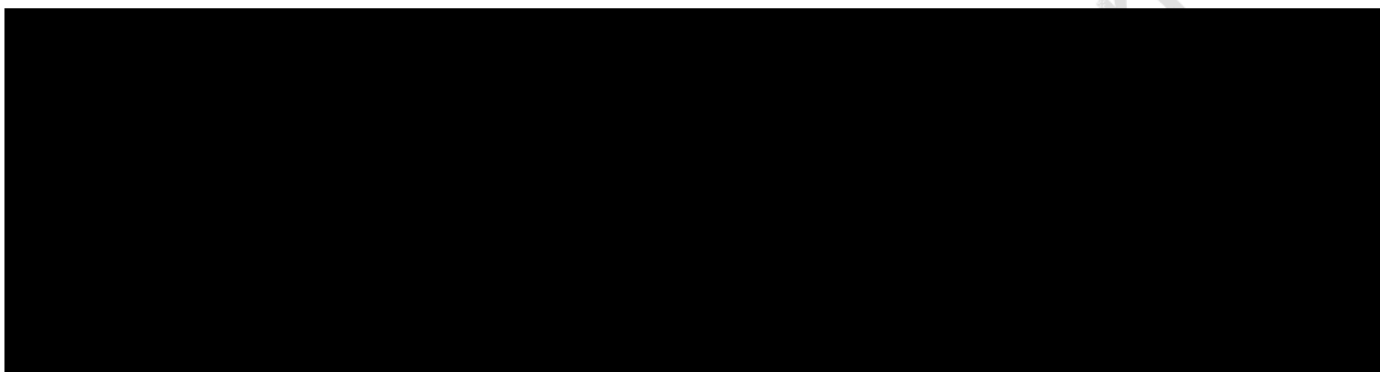

21.1 Moved Councillor Keen Seconded Councillor Strudwicke 2021/ 097

“that Council, having considered Item 21.1 – *Crown Land, Two Wells – February 2021* dated 22 February 2021, receives and notes the report and in doing so instructs the Chief Executive Officer to formally write to the Minister for Planning and the State Planning Commission reiterating Council’s position that it strongly objects to the creation of additional land zoned for retail exceeding 500 square metres in footprint threshold outside of the current Two Wells Town Centre zone on the basis that it doesn’t represent orderly urban planning.”

1. Pursuant to section 90(2) of the *Local Government Act 1999*, Council orders that all members of the public, except Chief Executive Officer, General Manager - Finance and Business, Acting General Manager Governance and Executive Office, Minute Taker/Administration and Executive Support Officer and Information Technology Officer be excluded from attendance at the meeting of Council for Agenda Item 21.2 – *Audit Committee Recommendation - Appointment of External Auditor*;
2. Council is satisfied that, pursuant to section 90(3)(d) of the *Local Government Act 1999*, Item 21.2 – *Audit Committee Recommendation - Appointment of External Auditor*; contains commercial information of a confidential nature (not being a trade secret), being proposals for service, the disclosure of which could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party and disclosure would, on balance, be contrary to the public interest; and
3. Council is satisfied that the principle that Council meetings should be conducted in a place open to the public has been outweighed by the need to keep the information, matter and discussion confidential.”
