

21.1 Drought Communities Programme Update - August 2019

RECOMMENDATION

OVERVIEW

<u>Purpose</u>

The purpose of this report is to provide Council with an update on the Drought Communities Programme and the processes undertaken to determine the final list of projects eligible for submission.

Background

In March 2019, Council was added to the regional council list for the extension of the Australian Government's Drought Communities Programme (the Programme) in regional South Australia. The Programme supports communities impacted by drought through funding local community infrastructure and other drought relief projects. After the Federal election in May 2019, Council was invited to submit an application to receive funding for projects up to \$1 million in total.

The intended <u>Outcomes</u> of the Programme are to:

- improve levels of economic activity in regions;
- increase productivity in regions;
- enable better retention of businesses, services and facilities; and,
- increase employment in regions by providing work for locals and/or farmers and farm labourers/staff/contractors whose employment opportunities have been affected by drought.

Each eligible council can receive funding for projects up to \$1 million. The grant amount will be up to 100% of eligible project costs. The minimum grant amount per application is \$25,000. Applications can include multiple unrelated activities up to the total funding amount of \$1 million.

<u>Eligible activities</u> must directly relate to the project and can include:

- repairs, maintenance, upgrading or building new community facilities;
- repairs, maintenance, upgrades, construction and fit-out of community spaces;
- employing local contractors to undertake repairs and maintenance;
- holding events; and,

• undertaking other drought relief activities.

Eligible expenditure items may include the cost of:

- suppliers, consultants and contracted labour undertaking eligible project activities;
- materials required to deliver eligible project activities;
- Purchasing, leasing or hiring equipment required to deliver eligible project activities;
- holding events; and,
- Other drought relief activities (including water carting for human consumption).

Each project must meet at least one of the following project requirements:

- lead to the employment of locals;
- contribute to the economic activity of communities/regions; or
- retain businesses, services and facilities.

The Programme will be managed entirely by Council and in strict accordance with the funding guidelines.

Discussion

The Programme criteria and draft matrix of project proposals for funding were presented at an Informal Gathering with Council Members on 4 July 2019. This session provided an opportunity for Management to workshop the programme criteria and draft matrix with members. The inclusion and benefits of employing a Programme Coordinator were also discussed and should be duly considered.

At its Ordinary Meeting of Council on 22 July 2019, an initial list of proposed projects and the assessment matrix developed based on the funding criteria, was presented to Council. Council then made the following resolutions:-

 - a. Subject to the inclusion of the Moquet Lee Memorial to the Pinery Fire to the value of \$32,000; and
 - *b.* Delegates authority to the Chief Executive Officer, in consideration of (a) above, to make the necessary adjustments; and
- 2. For any project considered ineligible by the Federal Government, submit remaining projects in order of ranking."

Since the 22 July 2019 Council meeting, Management has been working tirelessly with the many community groups, clubs and individuals to ensure that the proposed projects meet the required criteria, while maintaining confidentiality and seeking to avoid raising expectations too highly prior to approval of the funds.

The original project list approved by Council was also forwarded to the funding provider for an initial assessment.

On the 29 July 2019, Council was informed that the project completion date for the Drought Communities Programme for those councils selected as a result of the Federal election had been extended from 31 December 2019 to the 30 June 2020 (**Attachment 1**). While this news was welcomed, Management continued working on the current project listing and considered any value adding that could potentially occur over the course of the projects.

All projects submitted had a number of details that required researching, with the main issues being ownership, definition of licenced areas and the end use of the project. This feedback process initially ruled two projects out of contention due to the criteria, however, with further consultation with the funding provider, both projects were resubmitted back into the listing.

Project plans were created for all of the 15 projects including simple cash flow Project Plans – timing, costs, supplier, materials, and equipment.

The Local APC Business list was also updated as part of this process. It is anticipated that the programme funding will result in a significant injection of stimulus across the entire Council business region.

A productive internal workshop was held on Thursday 15 August 2019 that involved staff from all departments across the organisation. The fine-tuning of the funding application then took place, and the application was submitted on Wednesday 21 August 2019 with the following projects included:-

Conclusion

A final list of 15 projects under 13 sub-headings in 3 sub categories totalling a value of approximately \$1.6 Million Dollars has been submitted for funding (**Attachment 2**). It is also expected through further negotiations that value adding to the projects will be created when the financial announcements are made.

With the application submitted on Wednesday 21 August 2019, it is expected that Council will be informed regarding the outcome of the funding application in a maximum of two (2) weeks.

On 19 August 2018, the Australian Government announced the Drought Communities Programme -Extension to support communities impacted by drought. In March 2019, this support was extended to include an additional 15 drought–affected regions. During the election campaign the Australian Government committed to further extending this support to 14 drought-affected regions. The Drought Community Programme – Extension is designed to provide an immediate economic stimulus to drought-affected communities with this latest extension bringing the Programme to \$110 million. Each Eligible Council can receive funding for projects up to \$1 million.

Adelaide Plains Council is invited to apply for funding online at <u>https://portal.business.gov.au/</u>. To apply, you need to first register to use the online portal. Once registered, an application can be completed online. You will be prompted for an access code - please enter in **DCP@R2**

I encourage you to familiarise yourself with the program guidelines which you can find here

All projects need to be completed by **30 June 2020**. Accordingly, is advisable to make contact with contractors/service providers who you intend to carry out the work to confirm their availability and timings early to avoid missing out. **Do not submit multiple applications for individual projects, but rather bundle the projects up and submit together in one application**. Please be aware there will be no opportunity to extend projects and grant funding beyond 30 June 2020.

A **Frequently Asked Questions** document has been attached to this email to provide assistance and guidance for you around the range of projects and activities that this program will support.

To expedite the process I have also attached an **Accounts Payable form** for you to complete with the Council's bank account details. The earliest possible return of the form will ensure grant payments can be made in a timely manner.
