21.3 Drought Communities Programme – Stage 1 Amendment

EXECUTIVE SUMMARY

- This report is to inform Council of the need for an amendment to the approved project list for Drought Communities Programme Stage 1.
- Council needs to consider and endorse the removal of the proposed "Off-Leash" Dog Park at Lewiston, as this is no longer "shovel ready" and the replacement of a suitable project or projects to the same value of \$60,000.
- Upon the decision being made, the Federal Government will need to ratify this amendment, as part of the mid-DCP1 status report, to be submitted in early March.

RECOMMENDATION

"that Council, having considered Item 21.3 – Drought Communities Programme – Stage 1 Amendment, dated 24 February 2020:

- 1. Receives and notes the report
- 2. Recommends the following amendment to the previously approved project list removal of the "Off-Leash" Dog Park at Lewiston and replacement with the following project(s)
- 3. Delegates to the Chief Executive Officer that approval of the Federal Government for this amendment is sought, as part of Drought Communities Programme Stage 1 mid-term status report, due in early March 2020."

RISK ASSESSMENT

Reviewing and endorsing the amendment will ensure Council completes the DCP1 projects by 30 June 2020. A fair and impartial process is the result, ensuing that only "shovel ready" projects supporting local jobs and the local economy are recommended to the Federal Government - for approval and in turn being undertaken and completed.

DETAILED REPORT

Purpose

This report is to inform Council of the need for an amendment to the approved project list for Drought Communities Programme - Stage 1 (DCP1). Council needs to consider and endorse the removal of the proposed "Off-Leash" Dog Park at Lewiston, as this is no longer "shovel ready" and the replacement of a suitable project or projects to the same value of \$60,000. Once the decision is made, the Federal Government will need to ratify this amendment, as part of the mid-DCP1 status report, to be submitted in early March.

Background

In July 2019 Council endorsed the recommended DCP1 'shovel ready' project list (**Appendix 1**)., as per Resolution 2019/330 below. The overall project name supported by the Federal Government was titled "Stimulating and Sustaining Regional APC Businesses through Community Programs and Infrastructure Upgrades" and it was divided into three categories, namely Community Land Redevelopments, Sustainable Business and Tourism Attraction.

The successful projects were compiled using a different method to what is proposed for DCP2, where there were enough "shovel ready" projects able to be nominated and completed by the original and very short completion date of 31 December 2019. This was also able to be deliberated on quickly without the need to engage with community groups, as time was of the essence. Several projects were deemed less "shovel ready" than others, so these were not recommended for endorsement and they were placed on a "reserve" list at the bottom of the approved list, as per **Appendix 1**.

Moved Cr Lush Seconded Cr Keen 2019/330

"that Council, having considered Item 21.2 – Drought Communities Programme, dated 22 July 2019, instructs the Chief Executive Officer to:-

- 1. Formally submit the list of projects as identified in the Matrix (presented as Attachment 2 to this Report), noting that the total project funding threshold is \$1m:
 - a. Subject to the inclusion of the Moquet Lee Memorial to the Pinery Fire to the value of \$32,000; and
 - b. Delegates authority to the Chief Executive Officer, in consideration of (a) above, to make the necessary adjustments; and
- 2. For any project considered ineligible by the Federal Government, submit remaining projects in order of ranking."

CARRIED

After the Council endorsed project list was submitted to the Federal Government for assessment and approval, the date for completion was extended to 30 June 2020. This is still a tight time frame to

deliver the 15 approved projects, as the Federal Government advice that the projects were no longer confidential was not received until late August 2019.

Discussion

With the benefit of hindsight and the reduced amount of time to run before delivery of the projects is required by 30 June 2020, the Dog Park is no longer shovel ready. This change to no longer being "shovel ready", is primarily due to planning and flood management assessment delays. While Parts 1b. and 2. of Resolution 2019/330 above delegated any necessary amendments to the approved list to the Chief Executive Officer, with the total amount being \$60,000 and the next highest "shovel ready" projects being well above this amount, any such decision on the replacement project(s) is recommended to be nominated and endorsed by Council.

While the proposed Dog Park was one of the 12 approved community projects, it was not a "community group" driven project. Therefore it is likely that this project which is no longer "shovel ready", is able to be removed with minimal objection from the community.

The main difference between Round 1 and 2 is that the DCP1 successful projects were "shovel ready" projects ie able to be completed by the 30 June 2020 completion date. This was deliberated on efficiently without the need to formally engage with community groups, as is currently occurring with DCP2. This was primarily due to a backlog of community partnership projects not undertaken in recent years.

Several projects were deemed less "shovel ready" than others, so these were not recommended for endorsement, at that time. However, now one (or two) of those projects that was not nominated for funding last year, may be deemed to be suitable for delivery in the coming four months. Staff are able to provide further information to "reserve" projects, should this be required at 24 February 2020 meeting.

Management will continue to adopt a sound project management framework for managing and monitoring the remaining projects in DCP1. This will ensure that every effort is made to deliver the DCP1 projects on time and within budget.

Neither the original title nor the three categories will need to be amended, when the decision is made on which project(s) to add and the Federal Government will need to ratify this amendment, as part of the mid-DCP1 status report, to be submitted in early March.

Summary

It is recommended that the previously approved project list be amended with the removal of the "Off-Leash" Dog Park at Lewiston and replacement with a more shovel ready" project(s). This can then be submitted, considered and approved by the Federal Government - as part of the mid-DCP1 status report.
