- Council is required to adhere to the Copyright Act 1968. If a document has copyright protection then permission must be obtained from that person\organisation prior to copies being made. This permission must be in writing and obtained by the applicant. Where permission from the owner of the copyright in plans and other documents held by Council cannot be obtained Council is not obliged to provide a copy.
- Viewing of the plans/documents will be available at the Principal Office, 2A Wasleys Road, Mallala during normal business hours (9am-5pm).
- Some files may not be available and some due to storage location may need to be retrieved and may not be immediately available. Council has 10 business days to process your request.
