6.1 COVID-19 Financial Hardship Relief for Ratepayers

"that the Audit Committee, having considered Item 6.1 – *Coronavirus Financial Hardship Relief* for *Ratepayers*, dated 6 April 2020, receives and notes the report and in doing so recommends to Council that it implement the following:

- 1. Those impacted by COVID-19 (i.e. through becoming unemployed, underemployed or enduring business closure or financial hardship) may apply to Council for access to the following financial relief:
  - No fines or interest charged on overdue rates until 1 November 2020
  - Ratepayers can arrange to pay their rates weekly, fortnightly or monthly, based on an amount that suits their budget.
  - Ratepayers can postpone the fourth instalment of 2019/20 and the first instalment of 2020/21 up to 1 November 2020 without having to pay any fines or interest
- 2. Access to the financial hardship relief due to COVID-19 will be granted upon application."

6.2 Draft 2020/2021 Budget and Updated Long Term Financial Plan 2021-2030

"that Audit Committee, having considered Item 6.2 – *Draft 2020/2021 Budget and Updated Long Term Financial Plan 2021-2030*, dated 6 April 2020, receives and notes the report and in doing so endorses the following principles:

- Despite current economic challenges created by Covid-19 pandemic, financial decisions should be made based on the principle of long-term financial sustainability of the Council;
- 2. With a 1.89% increase in average rates, Council is expected to make a recurrent budget deficit of \$0.264m in the 2020/2021 Financial Year;
- 3. The estimated operating deficit from Council's two (2) Community Wastewater Management System (CWMS) is \$0.116m;
- 4. Council requires a further funding injection of \$0.314m to deliver its Operating Projects;
- 5. In order to provide the service levels outlined to the community in Council's Infrastructure and Assets Management Plans, Council has to spend \$2.549m on asset renewal in the 2020/2021 Financial Year;
- 6. Any decision to reduce capital spending in 2020/2021 from the required level of \$2.549m, may result in intergenerational inequity where the future generation of rate payers has to pay for the use of infrastructure assets by the current generation of rate payers; and
- 7. In recognition of both the current economic circumstances and of the benefits which can be derived from a planned infrastructure program the additional new capital expenditure added to the capital works program be removed and the new capital expenditure be bought to an amount more consistent with the current Long Term Financial Plan
- 8. That accuracy prevails in the setting of the Mallala CWMS annual service charge and that Council be provided with further analysis in this space prior to considering its draft 2020/2021 Annual Business Plan and Budget."
