## 2022 COUNCIL ELECTIONS

We were pleased to see the Adelaide Plains community show active interest in the election throughout each of the Nominate | Enrol | Vote phases of the 2022 Local Government Election. The State Average for voting, as reported by ECSA, was 34.54%. APC's voting participation was 30.81%.

With the general election now concluded, the changes to Council's composition and elector representation arrangements as determined through Council's Representation Review (completed in December 2021) have now taken effect – the previous ward structure is abolished and Council's composition is Mayor and nine Area Councillors.

### Scrutiny and Count

Scrutiny and count for the Mayoral election commenced at 9am on Saturday 12 November 2022 at the Mallala Council Chamber.

Due to the number of vacancies (9), and number of candidates (15), ECSA declared the election of Area Councillor to be 'complex' and as such this count was completed in two parts – to first preference on Saturday 12 November 2022 at the Mallala Chamber and the remainder of the count on Thursday 17 November 2022 at the ECSA Processing Centre in Hindmarsh SA.

### Results

ECSA confirmed the results on Friday 18 November 2022 and the successful candidates were sworn in as Council Members at the Ordinary Council Meeting on Monday 28 November 2022.

## YOUR DEPUTY MAYOR

Council, at its Ordinary Meeting on 28 November 2022, chose to appoint a Deputy Mayor and in doing so appointed Councillor Strudwicke as Council's Deputy Mayor for a 12-month term. Councillor Strudwicke has served as Council's Deputy Mayor since November 2018.

Appointing a deputy mayor is not mandatory however doing so promotes consistency, stability and contingency in the event the Mayor is absent and, in particular, ensures that the specific roles of the Mayor, set out within Section 58(1) of the Local Government Act continue to be delivered.

## MR PEPPINO (JOE) DANIELE

Mr Daniele served as a Councillor from 1975 to 2022 for the Two Wells Ward, and after his impressive 47 years of service to the sector, has taken the opportunity to enjoy retirement.

Joe has been a driving force behind development and the provision of community services in the Two Wells area, and played a pivotal role in the establishment of a Kindergarten in the township and lobbied to get a new Primary School built at Two Wells. He also supervised the construction of St. Joseph's Catholic Church



and assisted with building the Two Wells Community Centre. A passionate Councillor who served on various committees during his time, always striving to be a responsible representative of the ratepayers. **Thank you, Joe!**





## TWO WELLS TOWN CENTRE PROJECT

Council launched the long-awaited Two Wells Town Centre project in October 2022, focused on supporting the growth of Two Wells.

Following years of diligent planning, Council strategically purchased eight hectares of 'Crown Land' in the heart of the historic town, setting the foundation for an exceptional and vibrant town centre development opportunity.

The site, located between the Port Wakefield Highway, Old Port Wakefield Road and Wells Road – is to host a vibrant Town Centre precinct with a mix of retail, commercial, and community offerings complemented by high-quality landscaped and civic open spaces.

Council is driving a number of strategic projects across our region to support this growth, with the Two Wells Town Centre project being the largest of these, and a flagship offering for our community. Our Chief Executive Officer, Mr James Miller says "This project complements the significant pipeline of major projects focused on enhancing amenity in the Two Wells Town Centre. This includes the new Village Green, the Main Street streetscape masterplan, and planned undergrounding of powerlines in the Main Street. Key enabling infrastructure is also being established including major civil works to provide flood immunity for the town centre."

# FIRE DANGER SEASON 2022/2023 **PREPARE NOW!**

15 November  
2022 to  
30 April 2023\*

## If you haven't already, now is the time to prepare for Fire Danger Season.

Property owners are required to take reasonable steps to: protect property from fire, prevent or inhibit the outbreak or spread of fire, and minimise the threat to human life from fire, under the *Fire & Emergency Services Act 2005*.



## What are the requirements for my property this season?

You can help to protect your family, friends, pets, property and community from fire danger by following these requirements:

- **House blocks:** all dry flammable material is reduced to a maximum height of 10 cm by slashing, mowing or removing, and maintained throughout the year.
- **Larger blocks** (more than 0.5 hectare or 5,000 square metres): require a firebreak, slashed or mowed to a maximum height of 10 cm, to a minimum width of 20 metres around any dwelling, and a minimum width of 5 metres around other buildings and structures, and property boundaries, maintained throughout the year.
- **Vacant town blocks:** all dry flammable material is reduced to a maximum height of 10 cm by slashing, mowing or removing, and maintained throughout the year.
- All flammable material must be stored in a safe manner.

Council's Fire Prevention Officers inspect properties in the region to assess compliance with these requirements. Property owners issued with a Compliance Notice are required to comply with the requirements of that notice within 14 days. Failure to comply with a Compliance Notice carries a Maximum Penalty of \$10,000 and an Expiation Fee of \$473.

# NATIVE VEGETATION AND YOU

We all love the open landscaped character of Adelaide Plains townships, rural and coastal areas. Important legislation playing a key role in protecting our valued vegetation is the *Native Vegetation Act 1991* (the Act).

If you own a farm, business, or house in Adelaide Plains, the Act applies to your property. **Is there native vegetation on your land?**

South Australia's native vegetation is important because:

- It provides critical habitat for South Australia's unique native biodiversity.
- It helps protect our land, coastlines and waterways from erosion, salinity and climatic extremes, reducing the effects of a changing climate.
- It supports agricultural production through creating windbreaks, shelter for animals, and habitat for natural pest predators and crop pollinators.
- It improves our health and wellbeing by providing us with a connection to nature, and
- It is an important element of our state's natural identity.

Only 26% of native vegetation remains in SA's agricultural districts because of extensive land clearance. That's why it's important that we protect the remaining areas of native vegetation to support the health of the environment and the wellbeing of our communities.

## What is "Native Vegetation"?

Native vegetation is any naturally occurring species of plant that is indigenous to South Australia. This can include grasses, herbs, shrubs, trees, mistletoe, aquatic plants (like milfoil, reeds and sedges), marine plants (sea grasses) and, sometimes, even dead trees.

Planted vegetation is not covered by the Act unless it was:

- Intentionally sown or planted by a person in compliance with a planning condition.
- Planted with native vegetation clearance funds via an offset agreement.
- Planted under any other Act.

Significant and Regulated Tree legislation applying in metropolitan Adelaide does not apply in Adelaide Plains.

## How do I find out if I have native vegetation?

The Department for Environment and Water's online *Interactive Guide for Native Vegetation* is an easy to use tool to find out if your property has native vegetation.

## I want to clear native vegetation for my new development – what do I do?

If you are proposing a new development (including a shed or addition to your house) that requires clearing vegetation, you can contact the Native Vegetation Council to determine whether the vegetation is classed as native, and what level of clearance is required to remove it.

This clearance level determines if your application will need to be formally referred to the Native Vegetation section of the Department of Environment and Water.

As part of the development application process, you need to determine if the proposed development involves the clearance of native vegetation. If no clearance is proposed, you are required to provide a written declaration when lodging your application.

An Accredited Consultant must be engaged to prepare a Data Report if you're proposing to clear any native vegetation. This report needs to be provided when the lodging your development application. The report must contain a risk-based assessment determining the level of clearance proposed based on assessment criteria prescribed by the Native Vegetation Council.

## SWIMMING POOL & SPA SAFETY



We all like to keep cool as the summer weather heats up, and the idea of having your own backyard pool or spa is appealing. But are you aware of the risks and safety requirements?

Drowning is one of the most common causes of unintentional death in Australian children aged between 0-4 years, and backyard pools are one of the most dangerous water environments for young children.

Pools and spas are required to have safety barriers or fencing constructed in accordance with Australian Standards to restrict access to water by young children.

Development approval from Council is also required for a swimming pool or spa pool exceeding 300mm in depth or for an above ground or inflatable swimming pool or spa pool with a filtration system.

## MOWING AND WEEDS

Council mows and maintains our parks and reserves year-round to provide clean, attractive open spaces.

Irrigated spaces are mown weekly, and un-irrigated open spaces are mown every 3-4 weeks or as required. This is guided by Council's Parks and Reserves Classification.

Our slashing program kicks off in spring to ensure fuel load reduction slashing is completed for the Fire Danger Season.

Areas that are focused on include road verges in and around areas susceptible to bush fire such as Lewiston, Council reserves, and townships. We also slash and mow at intersections to provide adequate line of site for vehicles.

There are road verges within the region managed and maintained by the Department for Infrastructure and Transport. These include Port Wakefield Highway, Gawler Road, Mallala Road, Redbanks Road, Balaklava Road and Traeger Road (to the white guide post).



With above average rainfall this year, vegetation has grown quicker than normal! We're aware of this and have scheduled additional mowing and slashing.

## ILLEGAL DUMPING

Illegal dumping and litter not only impacts the use, appearance, and safety, of our public spaces and roadsides but it also negatively affects our natural environment. Cleaning of illegally dumped items, including tyres and asbestos, has significant costs to Council and ratepayers, and uses resources that could be focused elsewhere.
