 At clause 7.7, delete the words "In the case of an order of a specified duration, the duration of the order cannot be extended after the order has ceased to apply and the power to do so cannot be delegated" and insert the words:-

"In the case of an order of specified duration:-

- a. The duration of the order cannot be extended after the order has ceased to apply; and
- b. In any event, the power to extend the order cannot be delegated.";
- 2. At clause 5.8, delete the words "(is not a Section 41 Committee)";
- 3. Remove all references to 'Informal Gatherings' and 'Designated Informal Gatherings';
- 4. Delete clause 6.3; and
- 5. Insert a new clause between the current clause 13 and 14 and adjust clause numbers accordingly:
 - a. "14. Informal Gatherings

Council may hold informal gatherings or discussions provided that a matter which would ordinarily form part of the agenda for a formal meeting is not dealt with in such a way as to obtain, or effectively obtain, a decision on the matter outside of a formally constituted meeting of Council or a Council Committee. These are governed by Council's *Informal Gatherings Policy*."."

- 3. The Panel is satisfied that the principle that Council meetings should be conducted in a place open to the public has been outweighed by the need to keep the information, matter and discussion confidential."
