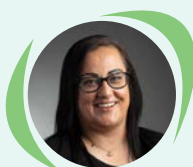

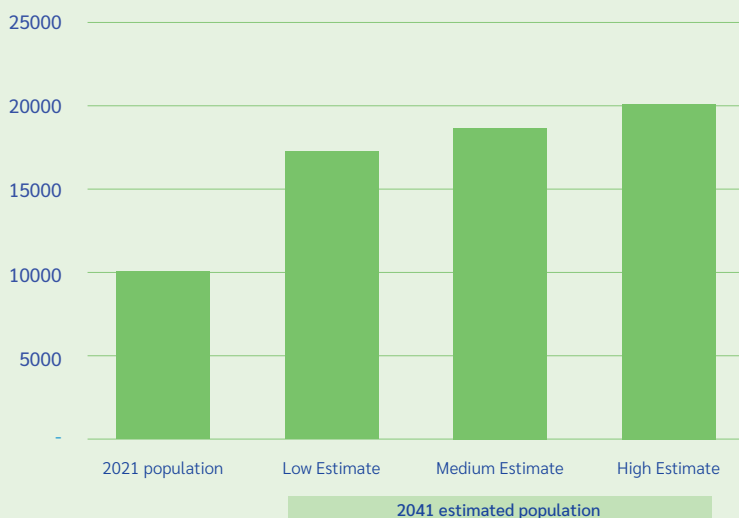
## The Growth Strategy helps us to:

- Identify actions that we can take in the next 5-10 years

## What does growth look like for my town?

80% of our estimated population growth will occur at Two Wells, with further growth in Mallala, Dublin and Lewiston.

**Dublin** is being investigated for long term growth. Dublin and nearby rural areas had 405 residents in 2021. Council is preparing a Dublin Township Growth and Tourism Master Plan to guide the town's future and growth. Subject to suitable infrastructure, engagement, and State Government support, Dublin may double in the long term future.

### Coastal and Rural Settlements

These settlements are established small communities surrounded by agricultural areas and the Adelaide International Bird Sanctuary – Winaityinaityi Pangkara. These constrain opportunities for growth. Thompson Beach has numerous vacant allotments anticipated to enable the town to eventually be around 400 residents.

**Two Wells** is experiencing 80% of Adelaide Plains' growth. Working towards a vision of a cohesive country community of 10,500, current projects include:

- Town Centre investigations
- Flood levee
- Subject to State Govt. approval, land to the north of Eden is being investigated for possible opening up for urban growth.
- Oval Precinct Master Planning
- Sewer investigations
- Main Street power line undergrounding
- Planning for walking and cycling
- Hart Reserve upgrade

**Mallala** could more than double in population over the next 10 years. Mallala and nearby rural areas had 1,042 residents in 2021. With rezoning in 2016, the Gracewood land division is proposing around 500 lots. This proposal is anticipated to take several years to be fully developed – possibly 5–10. When completed, Gracewood could accommodate around 1,300 residents, and Mallala could reach around 2,300 residents.

**Lewiston** is steadily growing as a rural living animal husbandry area. With 3,310 residents in 2021, and several land divisions being developed, some 4,000 residents in total are anticipated. Further residential land divisions are only possible if the State Government's Environment and Food Production Area is changed.

## CELEBRATING 20 YEARS OF SERVICE

The 20-year commitment of Councillor Marcus Strudwicke and Councillor Terry-Anne Keen was celebrated at the Local Government Association South Australia's April Ordinary General Meeting.

## EQUINE STRATEGY

A range of horse-based businesses and clubs call Adelaide Plains home. Many residents - in particular in Rural Living areas and through the Animal Husbandry Area in Lewiston - choose to live in the Adelaide Plains as they can have horses.

Recognising this significant sector, after investigations and consultation, an *Equine Strategy and Background Paper* was adopted in 2023. Strategies to be pursued include:

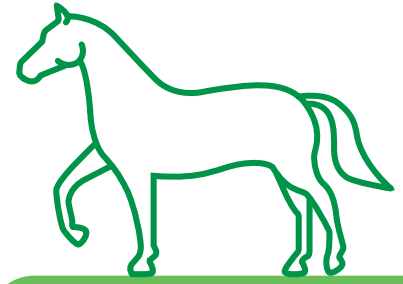
- Growing horse opportunities in the Lewiston Animal Husbandry Area
- Working with horse clubs
- Carefully managing shared trails
- Planning new trails
- Encouraging responsible horse riding
- Providing suitable horse infrastructure
- Keeping coastal horse activity at historic levels to support shorebirds.

This approach acknowledges Parham's historic role for horse visits, the important shorebird role of the foreshore, and encourages responsible rider behaviour.

## PARHAM HORSE FLOAT PARKING

Council has been investigating horse float parking at Parham for several years. This has involved several rounds of community engagement and ongoing input from the National Parks and Wildlife Service.

Drawing on engagement in 2022, Council has decided to:

- Continue horse float parking at Main Street, with upgrade works now being planned
- Communicate expectations of riders through a rider information sheet
- Ask horse clubs when planning a visit to apply for a permit in order to manage impacts.

## UPCOMING PUBLIC CONSULTATION

### Green Waste in Coastal Communities

Increased diversion of waste from landfill and capturing valuable resources for the circular economy are critical steps to reduce our region's carbon footprint.

Council continues to consider options to improve the recycling aspect of the waste services we provide. We want to find out if, and where, the demand is for green waste collection amongst our coastal communities.

Proposed green waste service options for the townships of Middle Beach, Thompson Beach, Webb Beach, and Parham, will be provided to residents to gather feedback by the end of 2023.

### Hart Reserve

Just a short walk or bike ride down Petticoat Lane from the Two Wells main street is Hart Reserve - a place we are transforming into a vibrant space for future generations.

The design for Hart Reserve considers innovation, flexible use, safety, accessibility, functionality, and environmental requirements. We are currently working with the award-winning skate park and youth space design agency Convic to develop a concept for a Skate Park or BMX Track within the Reserve after receiving community feedback.

We spoke to local skaters in May to find out their skill level and what features they may want in a new Skate Park in Two Wells. Once Convic has finalised their proposed design, we will again provide our community with the opportunity to contribute feedback. You can view the Hart Reserve Master Plan on Council's website.

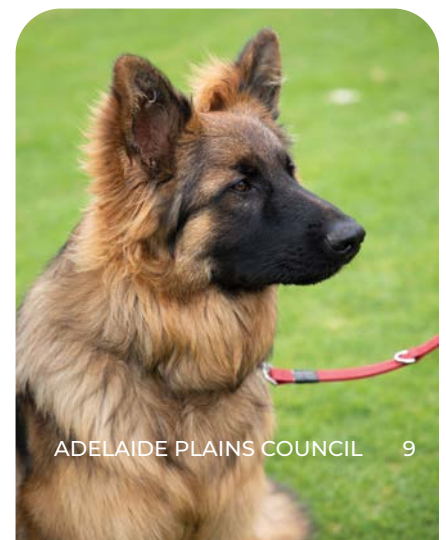

### Dog and Cat Management Plan

Our *Dog and Cat Management Plan 2022-2027* designates the Lewiston Wetlands and Reserves Trails as an area where dogs can be off-leash (when under effective control).

At our Public Forum in May, Council heard safety concerns from horse riders who use the trails, when there is potential conflict between dogs off-leash and their horses.

Over the coming months, we will be opening consultation on a proposal to designate the Lewiston Wetlands and Reserves Trails a dogs on-leash area under Council's Dogs By-Law 2019. If adopted, our Dog and Cat Management Plan 2022-2027 would then be amended as required to show the area designated for dogs on-leash.



## OWLS SPOTTED!

Nesting boxes were installed in several key locations around our region to encourage more native owls to move in, in an effort to protect biodiversity. Owls are skilled hunters, and play an important part in rodent control.

We are happy to report that Barn Owls and Southern Boobooks have been spotted in the Adelaide Plains using these boxes!

### Want to help native owls living near you?

Plant natives, install a nest box, and protect mature or dead trees (when safe to do so) that may have hollows providing a home for native wildlife.

## HELPING FAIRY TERNS

Fairy Terns are a nationally vulnerable species, and are endangered here in SA – with a population of approximately 1,000 mature individuals.

The birds typically nest in colonies on islands and estuaries and lay 1-2 eggs directly onto the sand – where they are very vulnerable to threats. These include natural threats like high tides and native predatory birds but also many new threats like, foxes, abundant gull and raven predator populations, and disturbance from people and dogs.

A small population of Fairy Terns breed on an offshore island in the Gulf St Vincent, and fly to places like Thompson Beach and Parham to feed on small bait fish. A collaboration between our Coastal Conservation Officer, Mallala Men's Shed, BirdLife Australia and Green Adelaide will see these chick shelters deployed around the breeding Fairy Tern colony next spring to offer protection for the chicks from avian predators and extreme weather events.

## PUBLIC FORUM

We held our first Public Forum for 2023 in Mallala on 1 May 2023. 15 community members met their elected representatives and had their voices heard on Council-related matters.

Topics discussed included dogs on/off-leash areas, waste management, and horse float parking, with Elected Members and the community gaining valuable insight.

A discussion summary was presented at the 22 May 2023 Ordinary Council Meeting.

# PROTECTED PLANTS ON OUR ROADSIDES

Every day you may drive past a critically endangered native plant, without even realising!

Our new roadside markers have been installed across 99 sites where native and/or threatened plant species have been found. There is limited native, natural vegetation left in South Australia – and much of the remaining native vegetation is on our roadsides.

Across our 99 sites 151 native plant species, 3 possible Threatened Ecological Communities (TECs) and 40 species of fauna were recorded.

One third of the sites are considered highly valuable (Type A vegetation). This means that the area of vegetation contains little to no invasive species, closely resembles probable pre-European conditions and/or contains a species or ecological community that is protected or threatened.

These new markers are a helpful reminder that even small spaces of vegetation hold great environmental importance.

Spotted our new blue roadside markers? If you live near one of these sites, please avoid mowing, spraying or clearing the roadside.

## Weed Profile BRIDAL CREEPER

*Asparagus asparagoides*, commonly known as Bridal Creeper, is a Weed of National Significance and a declared plant in South Australia.

It competes with and replaces native vegetation by forming thick, dense canopies and root mats, and smothers other plants. Together with the Northern Yorke Landscape Board (NYLB), we undertake control methods within vegetation areas of high conservation value.

### Looks like

It is a herbaceous climber with a rhizome and tubers, making it difficult to control. It is dormant in summer, with most growth occurring in June and flowering in late winter.

### How to manage

If you are a land owner, you are required to take reasonable steps to control the weed on your property and prevent its spread as best as possible.

## CAPITAL WORKS PROGRAM DELIVERED!



As a testament to our hard-working crew, our Capital Works Program for the 2022-2023 has not only been completed – but delivered on time, and under budget!

Our 2022 – 2023 Program totalled just under \$6 million, with an additional \$2.6 million of external funding.

In an era of increased costs, supplier delays and unpredictable weather our small but mighty Civil Team have worked tirelessly over the last 12 months, making every effort to deliver projects on time at an exceedingly high quality.

### Highlights include:

- Completion of our road sealing program covering 9.8km, adding 4 newly sealed roads.
- Completion of our re-sheet program with over 40km of roads re-sheeted.
- Began works on Middle Beach Road, with 60% of pavement works now completed.
- Processing over 200,000 tonnes of rock to deliver nearly 200,000 tonnes of quality rubble with our own team and our Contractors, saving a significant amount of money by supplying it ourselves.
- Upgraded plant (machinery and equipment) under budget and with significant savings.

## TWO WELLS MAIN STREET

### Current Projects

#### Undergrounding of power

Scheduled to begin by the end of July 2023

We are moving the powerlines along the Main Street (Old Port Wakefield Road) underground. The old lighting columns will be replaced with new, heritage style LED street lights.

Moving the current powerlines underground will provide a more reliable power supply, allow for an increased tree canopy, and better street lighting will improve safety at night!

Civil construction and installation of cables is scheduled to begin at the end of July, and will take approximately 12 months. Updated project timelines will be available on our website – these may change depending on a variety of factors including weather conditions and delivery of supplies. #### Roundabout

Due for completion December 2023

A roundabout is being installed at the intersection of Mallala Road, Old Port Wakefield Road and Meaney Road (entry to Liberty Estate). Construction will happen in two stages, with stage one being a temporary smaller roundabout to ensure safe pedestrian and traffic management.

### Transport assistance is available.

We are a partner council with the Mid North Community Passenger Network (MNCNP). The MNCNP provides a transport service for residents who are not able to access transport for medical and health appointments. Transport may also be arranged for shopping, banking, hairdressing and social appointments or visiting friends (conditions apply).

Community cars are based within each region, with Council's car based in Mallala. The cars are driven by volunteers who choose to give their time, energy, skills and experience to help others.
