

Regional Visit - His Excellency Hieu Van Le, Governor of South Australia

On Thursday, 9 July 2020 myself and Chief Executive Officer, James Miller were invited to an online discussion with the Governor of South Australia, the Honourable Mr Hieu Van Le. His Excellency was inquiring on matters within our Council area: — COVID-19 impacts, community resilience, horticulture and Northern Adelaide Irrigation Scheme (NAIS) water reuse, Councils ability to maintain operations as well as residential and business growth.

At the end of discussions, I invited His Excellency and Mrs Le to come and visit Adelaide Plains Council should his busy schedule permit and see for themselves the changes that are taking place. I was indeed pleasantly surprised when the Governor's office made contact and set 5 hours aside for an informal tour.

Consequently on Wednesday, 26 August 2020, His Excellency travelled with Mr Miller and myself as we took him on an informal tour within the timeframe that had been allocated. We looked at key areas the Governor was interested in:

- Mallala Men's Shed how it assists with mental health and recovery.
- Adelaide International Bird Sanctuary importance to the environment and tourism potential.
- Greenwheat Freekeh a locally grown business with big exports.
- Lunch at the Mallala Council Chambers to meet and greet Elected Members and staff a chance to have informal conversations.
- Viewing the NAIS water project lagoons on Porter Road, Lower Light.
- Viewing Perfection Fresh a massive horticultural enterprise.
- Liberty residential growth at Two Wells.
- Viewing the Xavier Two Wells Campus now under rapid construction.
